

Jewish Geriatric Chaplaincy Training

October 6, 2020 - April 27, 2021

Level I and Level II CPE: Dedham Campus

Introduction:

In the last 100 years, Hebrew SeniorLife (HSL) has grown from a small residence for frail elderly in Dorchester to a highly integrated system of care with an international reputation. HSL's system encompasses 650 chronic care hospital patients, groundbreaking geriatric research (Marcus Institute for Aging Research), palliative and hospice care, new models of sub-acute care, posthospital care, and home care.

Hebrew Rehabilitation Center (HRC) is the largest of HSL's institutions, with campuses in Boston and in Dedham. The Boston campus offers long-term care, short-term post-acute care, acute care, adult day care, and outpatient specialty services. Its most recent offering is the Center for Memory Health which provides diagnosis, education, treatment, and care coordination for older adults and their families. NewBridge on the Charles, located in Dedham, is HSL's newest campus. It offers independent and assisted living in addition to skilled nursing services and long-term chronic care. Most students will be assigned to clinical time on this campus.

Over 60% of our long-term chronic care patients in Boston are Jewish, with half of these being Jews from the former Soviet Union; in Dedham, closer to 85% are Jewish. Patients on our rehabilitation and post-acute services units reflect the more general population of the surrounding communities, including a broader mix of faiths and cultures.

Program Description:

CPE in a geriatric setting serves as important preparation for the congregational rabbinate/cantorate/ministry, as well as for health care chaplaincy positions. Chaplains support the spiritual and emotional lives of all patients in ways that

enhance their overall health and wellbeing. In addition, chaplains help the caregiving staff manage the ongoing emotional demands of their work, which include the presence of death and loss on a regular basis, and understand the spiritual aspects of their patients' needs. Our setting requires that chaplains be attuned to Jewish religious/cultural approaches patients have while facing the challenges of aging, loss, end of life decision making, dementia, and seeking spiritual fulfillment in their later years.

Our curriculum addresses spiritual care as it relates to aging, illnesses of aging (including dementia), family caregivers, bioethical decision-making, dying, and bereavement. Special attention is given to cultural and demographic diversity impacting the spiritual issues of older adults, including trauma-informed care, recognizing resilience, working with patients with dementia, LGBT identities, and being "not religious." Students serve as chaplain interns on assigned HSL units, providing spiritual care to patients, families, and staff. Our primary lens is that of Jewish spiritual care; students who wish to learn about spiritual care from the perspective of other religious/spiritual traditions are invited to make this one of their learning goals.

English is the predominant language of the educational program, and applicants must be fluent in spoken and written English. Special opportunities are available for Russian-speaking applicants, as a significant portion of HSL residents and patients speak Russian; some allowances can be negotiated individually for Russian-speaking students who need to do some of their assignments orally rather than in writing.

This unit of CPE is aimed at chaplains, congregational clergy, seminary and rabbinical students, and laypersons interested in pursuing spiritual care.

Dates: October 6, 2020 – April 27, 2021.

Times: Class day is Tuesday, 9-3:30, on the Newbridge Campus in Dedham. Class does not meet on national or Jewish holidays or during typical public school vacation weeks. An additional 10 hours of clinical work is required weekly, which can be scheduled according to the student's convenience, beginning the week of October 19. (Formal clinical time may begin earlier for returning students.) The program requirement of leading four services, classes, or groups may involve occasional attendance at HSL outside typical clinical hours. Written assignments and readings are also completed outside of the on-site time frame. Individual supervision will be scheduled for one hour biweekly. The CPE program does not require overnight call, and is appropriate for students who are shomer/et Shabbat. Students must be able to document a minimum of 100 educational hours, a minimum of 250 clinical hours, and a total of 400 hours spent in the CPE program in order to get credit for the unit.

No planned absences will be permitted during orientation (first 3 class sessions), Midunit evaluations, or Final evaluations.

Faculty: Rabbi Beth Naditch, ACPE Certified Educator and Board certified chaplain, will lead this unit. Several guest speakers will bring their expertise to the didactic part of the curriculum.

Cost: Cost: \$25 application fee. Minimum tuition payment of \$1200; suggested tuition payment of \$2000. For IRS purposes, value received per student is \$1200, with the balance of the tuition being a tax-deductible gift to Hebrew SeniorLife's Chaplaincy Institute. \$250 non-refundable deposit upon accepting a position in the program is credited toward the total tuition payment.

Application process: Applications are due March 15, 2020. Applicants should read the <u>Annual Notice</u>, <u>Admission policy</u>, <u>Use of Clinical Materials Consent</u> <u>Form</u>, and <u>Financial policy</u>, and then fill out the standard <u>ACPE application form</u>.

When your application is received, we will set up an in person interview, or, for applicants outside the Boston area, by Zoom. Rabbi Beth Naditch and another member of the CPE program's Professional Advisory Committee or a member of the spiritual care department will share in the interviewing. We will send a form by email to your references. Please let them know they do not need to send anything to us before then. You will be informed of the admissions decision within one month of your interview. The decision is at the sole discretion of HSL.

International students have often rented a car or participated in a car swap for the duration of the program. Parking at NewBridge is free.

Housing, Meals, and Accommodations: We are happy to assist international students in finding host families, although we cannot offer housing. All students are also welcome to explore dormitory options at local theological schools. NewBridge has a kosher deli and a non-kosher salad bar and coffee/ice cream option where students can purchase food Monday through Friday.
